This privacy statement was last modified on 12/30/2018.

Via the website of Ermalo Technical Supply B.V. (hereinafter: ETS) privacy-sensitive data or personal data are processed. ETS considers careful handling of personal data of great importance. Personal data is therefore carefully processed and secured by us. In our processing, we adhere to the requirements of privacy legislation. This means, among other things, that:

We use the legal retention period of 7 years, depending on the data and documents. We only use this retention period when it comes to data that must be kept for so long on the basis of tax legislation. We keep the other data for 1 year after the end of the agreement.

Confidentiality & Disclosure to Third Parties

We treat your personal data confidentially. We do not provide the personal data that we collect via our website to third parties for direct marketing purposes of these parties. Furthermore, we will not provide the information you provide to other parties, unless this is necessary in the context of the performance of the agreement or we are allowed or required to do so by law.
